3 hereby submit this Notice of Errata.


4 MLG Automotive Law, APLC is the attorney for the Debtor in Case Number

I, Matthew S. Grayson, Esq., hereby declare and state as follows:


1. I have personal knowledge of each fact stated in this Declaration. If called upon to testify as to the information set forth herein, I could and would do so competently.
